- Only **fresh graduates** are eligible; previous pass-outs are not covered.

Required Documents

Applicants must upload the following documents during submission:

- **Graduation certificate/mark sheet** (Proof of passing in 2025).
- **Identity proof** (Aadhaar card).
- **Bank account details** (Passbook copy or cancelled cheque for DBT transfer).
- **Residential proof** (Domicile certificate or equivalent).
- **Self-declaration** (being issued in the college office)
